- ✈ Valid UAE GCAA Medical Certificate.
- ✈ Valid ELP

COURSE DURATION

The duration of the course is between 2 days to 5 days based on the lapsed of the rating.

TRAINING PROGRAM

The course program will depend on the student's lapsed of Instrument Rating or Class Rating. Below are the brief details of course period depends on the lapsed of the ratings.

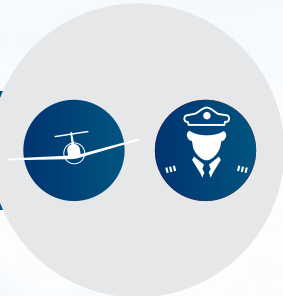

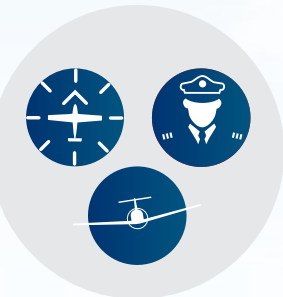

PAYMENT SCHEDULE
